## **Authorization to Deduct Educational Expenses**

In order to expedite processing of your financial aid\*\* disbursements, with your authorization Florida State College at Jacksonville (FSCJ) will deduct from financial aid\*\* the following educationally related charges (if applicable) for all semesters of your enrollment:

- monies owed from a prior academic year (if funds are available). FSCJ will deduct a maximum of \$200 from current year Title IV funds to pay a prior year's balance. FSCJ will deduct funds from other sources up to the amount of your past balance.

I understand that I am responsible for payment in full of charges that I incur at FSCJ. If my financial aid is reduced, terminated, or otherwise insufficient to pay charges, I will pay the remaining balance by the due date. Failure to remit payment will result in a restriction from further registration, withholding of academic transcripts and diplomas, and my debt will be forwarded to a collection agency and collection costs of up to 30% will be assessed.

I understand that if I do not wish to agree to the terms above or want to later cancel this authorization, I must submit to the Campus Business Affairs Office a complete form BRSR 002, Termination of Authorization to Deduct Allowable Charges from Federal Student Aid, which can be obtained on FSCJ's website. I understand that the BRSR 002 form will be effective from the date that it is received by FSCJ and is not retroactive. If a BRSR 002 is on file, I understand that a deferment of charges pending financial aid disbursement will not be available and that all charges including tuition and fees must be paid by me from my own resources.
